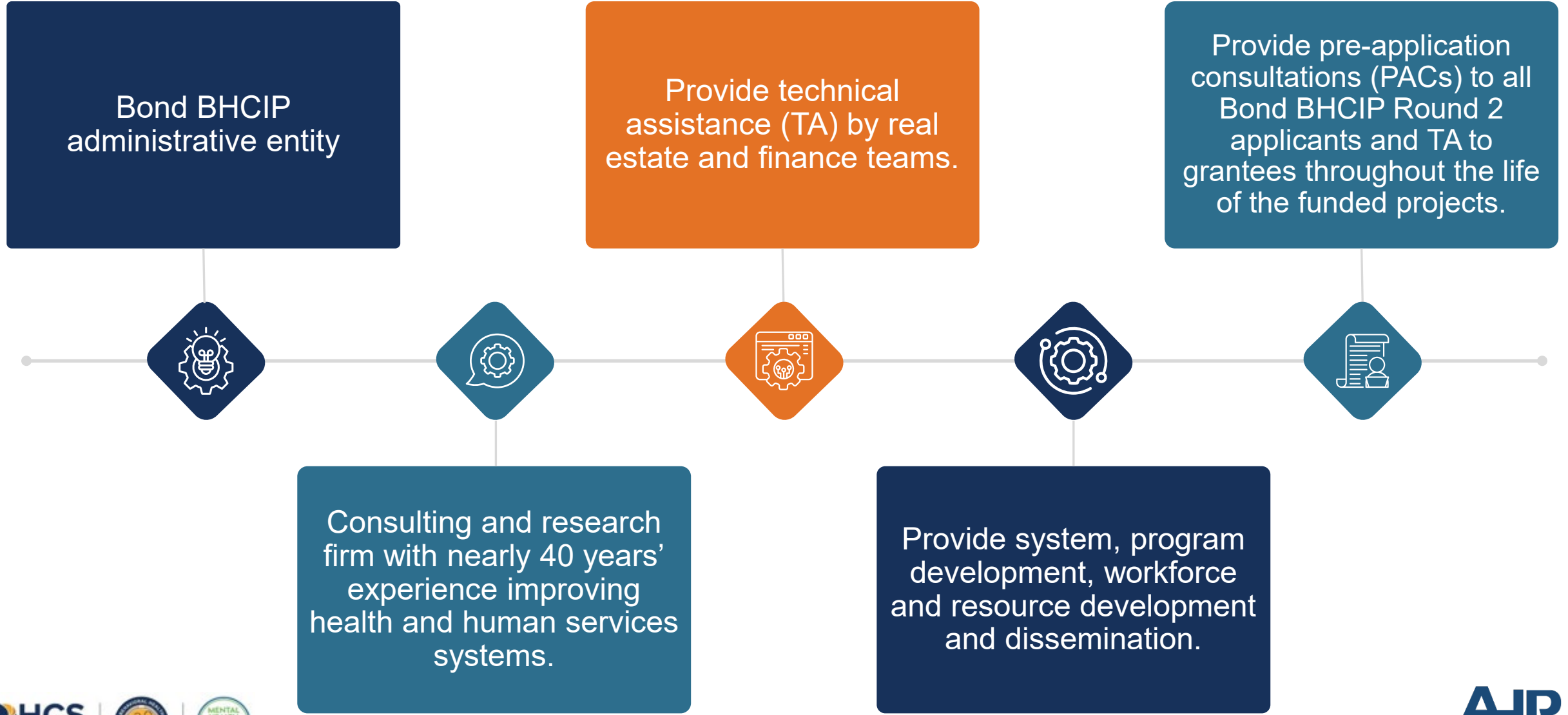

Proposition 1



Behavioral Health Transformation

In March 2024, California voters passed Proposition 1, a two-bill package to modernize the state's behavioral health care system, improve accountability and increase transparency, and expand the capacity of behavioral health care facilities for Californians.

Behavioral Health Services Act ([SB 326](#))

- » Reforming behavioral health care funding to provide services to those with the most serious mental illnesses and treat substance use disorders.
- » Expanding the behavioral health workforce to reflect and connect with California's diverse population.
- » Focusing on outcomes, accountability, and equity.

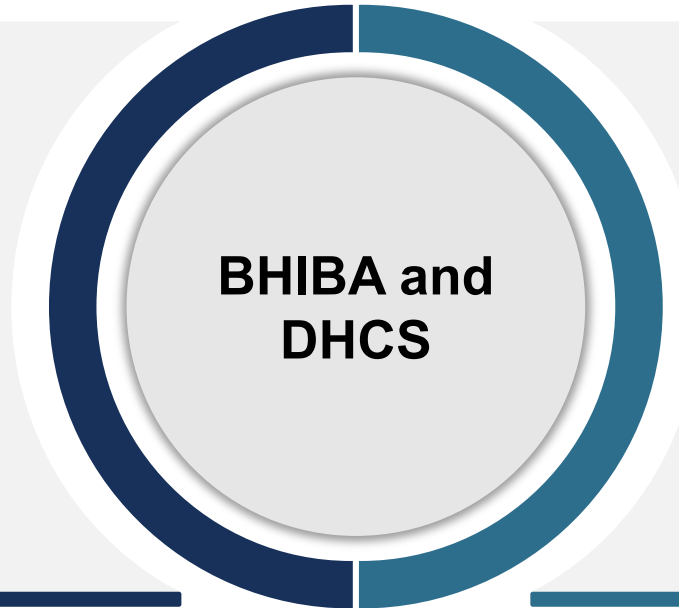
Behavioral Health Infrastructure Bond Act of 2024 (BHIBA) ([AB 531](#))

- » Funding behavioral health treatment beds, supportive housing, and community sites.
- » Directs funding for housing for veterans with behavioral health needs.

BHIBA and DHCS



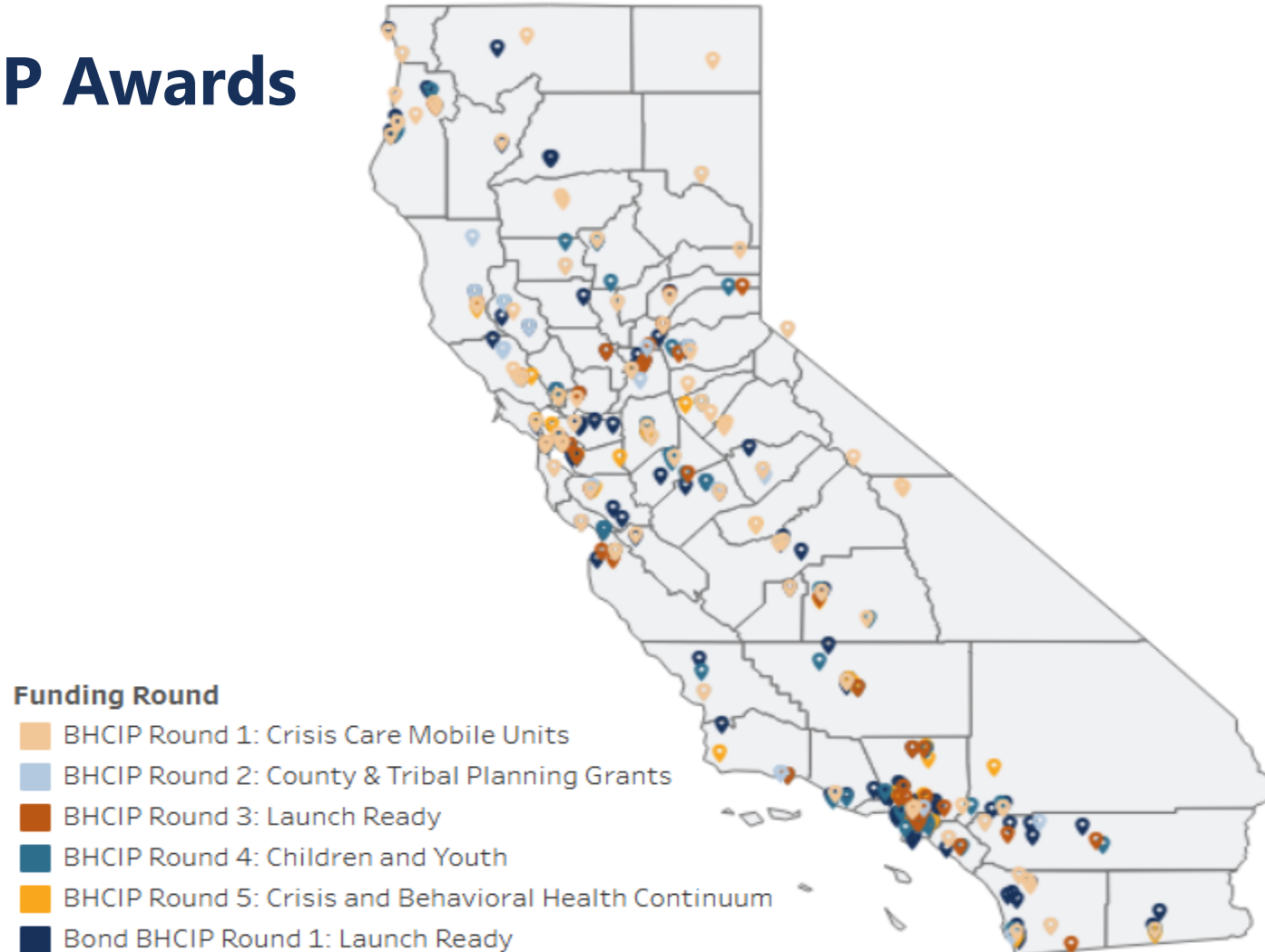
The BHIBA portion is a \$6.38 billion general obligation bond to develop an array of behavioral health treatment, residential care settings, and supportive housing to help provide appropriate care facilities for individuals experiencing mental health and substance use disorders.



Of these funds, DHCS was authorized to award up to \$4.4 billion in BHIBA funds for BHCIP competitive grants to expand behavioral health facility infrastructure.

The LAO (Legislative Analyst's Office) Report

- The LAO evaluated how Proposition 1 bond funding could be strategically used to address gaps in behavioral health services.
- DHCS utilized the LAO report along with other sources to ensure Bond BHCIP Round 2: Unmet Needs funding focuses on the remaining gaps in the statewide behavioral health continuum and prioritizes mental health community residential beds and crisis settings.
- DHCS also aims to distribute grant funds to rural/remote areas with outstanding behavioral health needs or insufficient behavioral health infrastructure, and geographic areas with no prior BHCIP infrastructure projects. In addition, DHCS is prioritizing regional models aimed at constructing, renovating, and/or expanding community-based services.

Bond BHCIP Guiding Principles and Priorities



Bond BHCIP Guiding Principles and Priorities

- **Address urgent needs in the care continuum** for people with mental health or substance use conditions, including unhoused people, veterans, older adults, adults with disabilities, and children and youth.
- **Invest in behavioral health and community care options** that advance health equity of behavioral health care and community options.
- **Increase options across the life span** that serve as an alternative to incarceration, hospitalization, homelessness, and institutionalization.
- **Meet the needs of vulnerable populations** with the greatest barriers to access, including people experiencing unsheltered homelessness and justice involvement.
- **Ensure care can be provided in the least restrictive settings** to support community integration, choice, and autonomy.
- **Leverage county and Medi-Cal investments** to support ongoing sustainability.
- **Leverage the historic state investments** in housing and homelessness.

Bond BHCIP: "Tribal Entity" Definition

In accordance with [Section 5960.35](#) of the Welfare and Institutions Code, a "Tribal entity shall mean a federally recognized Indian tribe, Tribal organization, or urban Indian organization, as defined in [Section 1603](#) of Title 25 of the United States Code."

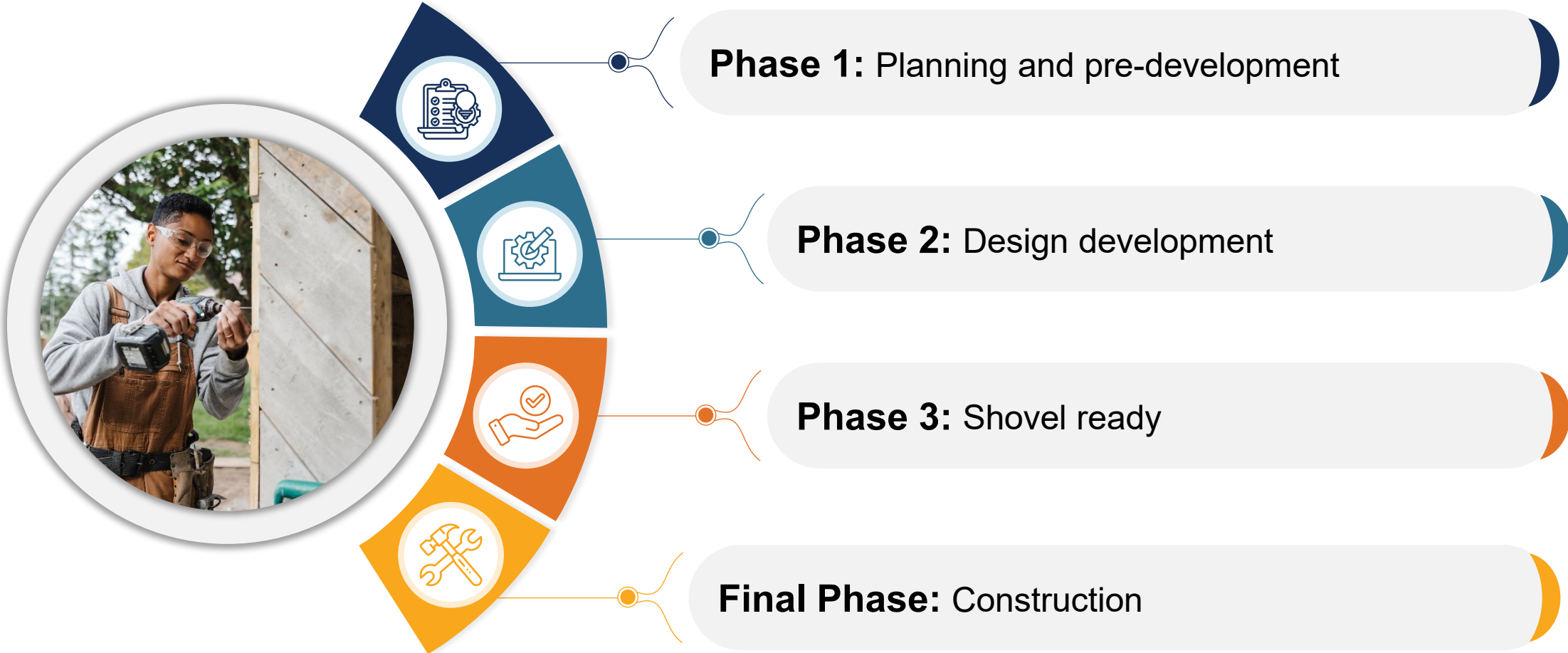

Licensing, Certification, and Accreditation (RFA Section 2.1)



Tribal entities along with all other eligible applicant entity types are subject to state licensing and/or certification requirements based on the proposed facility type.

Technical assistance (TA) will be made available during PACs, including additional information and guidance about the facility licensing and certification process.

County and Stakeholder Support: All Applicants

(RFA Section 2.1)

- At the time of application, a Tribal entity, must include a letter of support from the Tribal council, chairperson, or Tribal authorizing entity.
 - Director of the county behavioral health agency where the project is located (required of city, nonprofit, for-profit, or Tribal entities, with the exception of those projects on Tribal land)
 - Tribal board (required for all projects on Tribal land; can be a Tribal resolution)
 - Applicant's board (required of all applicants, except those with projects on Tribal land)
- If the project is considered a regional collaboration, the applicant must provide an LOS from a county official or a Tribal representative from the collaborating county(ies) or Tribal entity(ies), as appropriate, detailing the collaboration.
- For additional guidance, see RFA Attachment C: Letters of Support Guidelines.
- **Form 7: Community Engagement** - Applicant has engaged with community members and other stakeholders through scheduled meetings, focus groups, and surveys.

Match Requirements



What Is Match?

Cash

Cash is the strongest form of match and can come from a variety of sources, depending on the applicant. Applicants must document their ability to pledge the required match in cash, including providing bank statements and investment statements showing available cash on hand.

In-Kind Property Equity

Applicants may pledge the in-kind equity value of property where the facility will be located and if the entire assessor's parcel number (APN) of the property being pledged for match is dedicated to the new development project, so long as the property is NOT funded by BHCIP or Bond BHCIP funds.

Acquisitions made before the date of the Bond BHCIP Notice of Conditional Award can be claimed as property match if there is equity or may be claimed as sunk cost match. It can NOT be reimbursed.

Sunk Costs

Eligible expenditures directly related to the development of the proposed Project may be submitted for review as sunk cost match, no later than seven (7) calendar days after the date of the Notice of Conditional Award.

Project sunk costs exceeding one (1) year prior to the date of the Bond BHCIP Notice of Conditional Award may NOT be claimed as part of the match requirement.

Sunk costs are NOT eligible for reimbursement.

Bond Funding

Bond BHCIP: Unmet Needs Projected Funding Schedule and Cash Flow Management

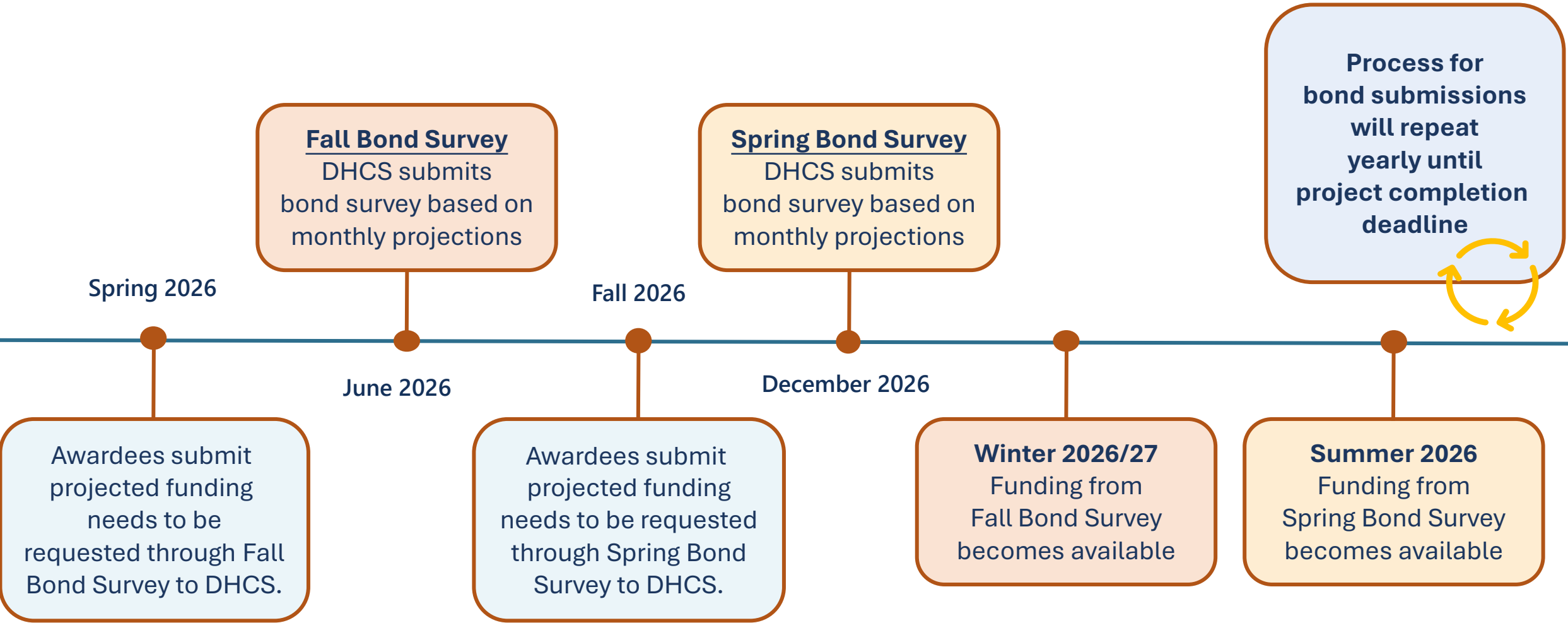
Conditional awardees must submit an accurate, detailed estimate of their project's monthly funding needs for the entire life of the project period **no later than the 15th of each month.**

Ongoing Bond BHCIP funding in any-month period is **dependent on the accuracy of each awardee's projected funding needs** and requires final approval from the State Treasurer's Office.

Bond BHCIP funding received based on bond survey submittals must be spent **within three (3) years of the date of issuance.**

Overall awarded funding for Bond BHCIP must be fully expended **within five (5) years of receipt of the Notice of Conditional Award.**

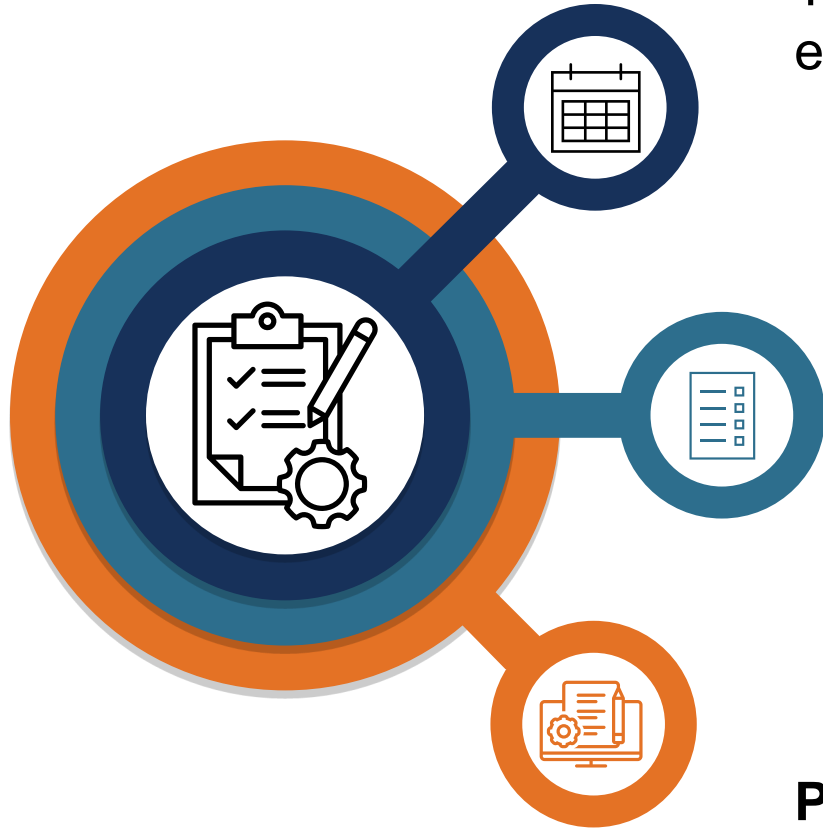

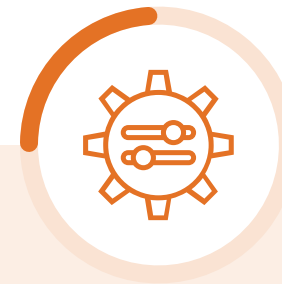
Tips for Applying: Ensuring Consistency



Double check application responses to ensure there is no conflicting information.



Write a strong narrative in all applicable sections of the application and ensure all data matches across the application (beds/slots, populations served, etc.).



Many questions include multiple parts, so confirm that you have responded to all parts of each question.

New Requirement: Photo Submission

Photo of Proposed Property in pre-Bond BHCIP stage is required with your application.

High-quality photo should be in a JPG format with size of 1024x768 pixels or larger, not to exceed 15MB in file size.

*A PDF will be an acceptable alternative file format.



Tips for Applying: Picking a Project Name

If awarded, your project title will serve as the public name of the project and will be referenced publicly in communications such as news releases, information about groundbreaking and other events, and more. Thus, submitting your application with a carefully thought-out project name is extremely important.

Things to avoid when creating a project name:

- Including an address: 123 Main Street Behavioral Services Recovery
- Referencing a legislative bill: SB444 Mental Health Center

Things to consider including in your project name:

- Choose a name that is meaningful and relevant to your project/facility.
- Reflect the ages and health needs of the target population.
- Focus on positivity and transformation, suggesting positive outcomes or a journey.
- Include words that emphasize compassion and support, connecting warmth and understanding to your project.

Tips for Applying: Bed and Slot Definitions

Bed



Bed refers to a physical bed in a facility that can accommodate one person per 24-hour period.

Slot



A slot is defined as a treatment “chair” an individual uses for receiving behavioral health treatment outpatient services that do not require overnight stays.

Tips for Applying: Regional Model



A regional model is described as counties and/or Tribal entities partnering to create established networks of organized systems of care. This may include two or more counties that propose a facility that will provide behavioral health services to residents of all counties involved.



Tips for Applying: Campus

“Campus” is defined as three or more eligible behavioral health facilities that are collocated at the same site, including existing facility types (non-BHCIP/Bond BHCIP funded) and Bond BHCIP Round 2- proposed facilities.



Tips for Applying: Narrative Questions

Narratives Overview

- Describe how the proposed project will address health priorities and unmet needs within the community(ies) to be served.
- Describe how the proposed project fits into and bolsters the behavioral health continuum of care within the region. Answer narrative questions without the use of Artificial Intelligence (AI) so answers are specific and authentic, and come from the individuals involved in the project rather than artificially.
- Describe the types of service(s) and level of care designation(s) that will be offered in the facility(ies) once the project has been completed. Describe how the proposed project facility(ies) will receive referrals into the program.
- Explain whether the proposed facility(ies) will have established connections to step-up/-down services.
- Provide a high-quality abstract summarizing the project, explaining why it is necessary, how it addresses the remaining gaps in the statewide behavioral health continuum, and how it addresses unmet needs as identified in the RFA.

Tips for Applying: License and Certification Resources

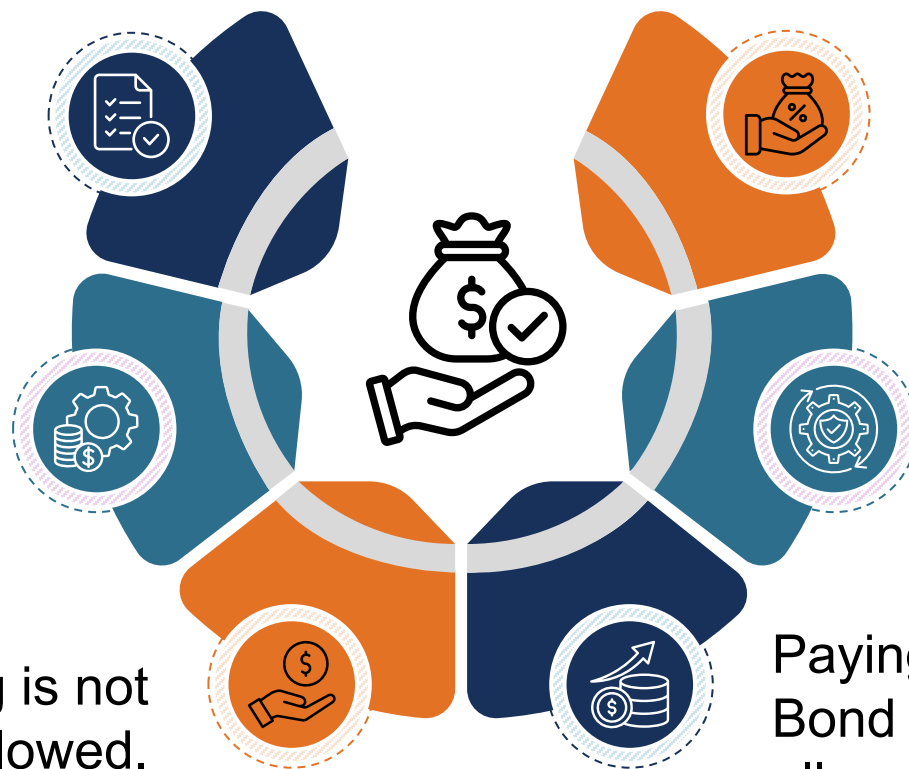

Tips for Applying: Allowable and Not Allowable Expenses

[Attachment B: Allowable and Not Allowable Equipment List](#)

Relocation costs are not allowed.

Preservation funding is not allowed.



Paying off existing loans with Bond BHCIP Round 2 award funding is not allowed.

Paying facility operational costs with Bond BHCIP Round 2 funds is not allowed.

Paying off interest on loans with Bond BHCIP Round 2 funds is not allowed.

Tips for Applying



Site Control

- Title must be vested to the lead and/or co-applicant (confirm via current title report).
- Accepted documents: title report, executed purchase and sale agreement (PSA), letter of intent (LOI), long-term lease (≥ 30 yrs), or executed exclusive negotiation agreement (ENA)
- Include key dates: execution, expiration, option periods
- Match entity and property information: legal names and address/assessor's parcel number (APN) must align.
- Lease terms must meet program requirements (extend if needed).








Co-applicants

Co-applicants bear the same legal and/or fiscal responsibilities associated with the grant as applicants, and both are expected to sign the Program Funding Agreement.

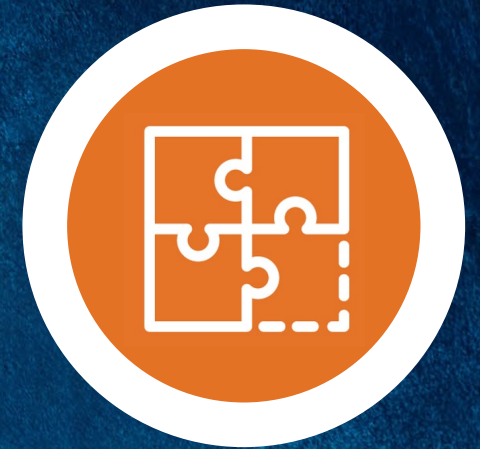


The applying entity can not be modified post-award.

Reasons for Disqualification from Review

-  ● The applicant does not request a PAC by the August 29, 2025, deadline (see RFA section 1.4).
-  ● The application is received after the application submission deadline of October 28, 2025, at 5:00 p.m. PT. Submit early to avoid technical issues. See RFA section 1.4 for a complete timeline.
-  ● The application is incomplete or missing required information or forms or does not include a complete development budget (see RFA section 2.8).
-  ● The proposed facility is not on the list of eligible facility types (see RFA section 2.4).
-  ● The project is in some way ineligible for funding (see RFA section 2.2).

Post-Award Expectations



Conditional Awards for Bond BHCIP Grant Funding

- The conditional Bond BHCIP grant award remains contingent upon verification of the grantee's eligibility and use of bond funds, completion of award certification steps, final execution of the Program Funding Agreement, and fulfillment of all program requirements.
- For Bond BHCIP Round 2: Unmet Needs, conditional awards will undergo a uniform vetting process before final awards are announced.
- Once the vetting process, which occurs after issuance if the conditional award, is complete, DHCS may rescind a conditional funding award in any instance in which a grantee does not meet program and/or bond funding requirements or if any of the areas indicated below are found to be problematic or inconsistent with statutory requirements.
- DHCS' vetting process includes conducting in-depth reviews of property, liens and loans, funding streams or conflicts, match, business structure, budget proposal, and overall application accuracy.
- Bond BHCIP Round 2: Unmet Needs projects will need to meet federal, state, and local laws, with the exception of Tribal projects on Tribal lands.

Post-Award Process and Expectations



• Clear title to the property.



• Complete execution of the Program Funding Agreement (PFA) within 90 days of receipt.



• Execute a Facility Access Agreement (FAA).



• Provide a signed opinion letter from legal counsel stating that the PFA, including real estate instruments, along with the program requirements, is not in conflict with any existing contract or agreement related to the property, project, or conditional grantee.



Important Points:

- The PFA must be signed, returned, and fully executed with DHCS/AHP before initial funding will begin.
- DHCS will not accept any changes, negotiations, or redlining to the PFA.

Encumbrance and Use Restrictions

Commit to operating behavioral health services in the Bond BHCIP Round 2 funded project for a minimum of 30 years through a deed restriction placed on the property title.

Must accept Medi-Cal beneficiaries and serve at least the same percentage, as identified in their DHCS-approved Bond BHCIP Round 2 grant project.

Bond BHCIP Round 2 Conditional Awardees—whether individually or with co-applicant—hold the same responsibilities and obligations to fulfill the Program requirements for the duration of the deed restriction.

All entities involved in the proposed facility(ies) must be clearly identified in the application, with their defined roles on the Bond BHCIP Round 2 grant project.



Encumbrance and Use Restrictions

01

Encumbrance requirements are dependent on project property ownership with exceptions primarily on Tribal projects on Tribal lands.

02

Non-applicant project property owners or co-owners are required to:

- ✓ execute the Facility Access Agreement (FAA) and
- ✓ sign and record the security instruments: Declaration of Restrictions (DoR) and Performance Deed of Trust (PDoT)

03

If the project property is leased, the lead applicant and any co-applicants are required to be a party to the lease agreement.
